### **OUR HISTORY**

In the fall of 2019, a group of individuals which would later become the initial board members of Sandhills First Steps began to notice the number of expectant working mothers in Burwell compared with the number of available child care spots. As the board brainstormed ways to serve the community's child care needs, the most natural place to start was with existing child care providers. While some providers were willing to consider expanding their current capacity, there are many challenges that come with expansion. Additionally, even with current providers increasing their capacity, there would likely still remain a gap of available child care spots. Thus, the idea of building a new child development center emerged.

In January of 2020, Sandhills First Steps applied and was accepted to be a Communities For Kids (C4K) community through the Nebraska Children and Families Foundation. This partnership opened the door to network with child care experts across the state and provided startup funding to begin educational efforts and hire community coordinators to conduct further research and feasibility studies. The C4K partnership also allowed Sandhills First Steps to gather a broader scope of data and in July of 2020, a C4K survey of Burwell and the surrounding area was conducted, validating the original concerns of lack of child care in the community.



"Children's experiences, interactions and environments in the first three years form the bedrock upon which all future development is built. It is simply the best time to steer children toward lifelong learning, health and success."


